December Updates

HRB allocates €20 million for eight program awards targeting dementia, breastfeeding, speech and language interventions, autoimmune disease, pandemic preparedness, and climate-resilient healthcare. Notably, two projects support mental health aligning with the national strategy, Sharing the Vision. The Applied Programme Awards aim for highimpact, team-based research, addressing evidence gaps and building on previous HRBfunded work. Dr. Mairéad O'Driscoll, HRB Chief Executive, emphasizes alignment with HRB and wider health priorities, expressing gratitude for additional support. The awards emphasize swift translation of research into policy and practice, with an emphasis on user involvement, according to Dr. Anne Cody, Head of Investigator-Led Grants. Noteworthy recipients include projects on mental health, Sjögren's syndrome, dementia, climate-resilient healthcare, language intervention, and breastfeeding support. Award values range from €2,445,580 to €2,558,926.

The 12th Palliative Care Research Network (PCRN) Symposium, hosted by the All Ireland Association for Hospice and Palliative Care at Dublin's Ashling Hotel on December 7th, centered on the theme 'Implementation of Research for Evidence-Based Practice'. During the event, a Special Interest Group (SIG) in Dementia Palliative Care, led by Dr. Siobhán Fox, Lecturer in the CGR, was inaugurated. Expressions of interest for group membership can be submitted at this link. Dr. Siobhán Fox also presented research from the Model for Dementia Palliative Care Project. Her oral presentation, "A Comparison of Four Dementia Palliative Care Services using the RE-AIM Framework," and poster, "Views on an Irish model for dementia palliative care," contributed to the symposium's insightful discussions.

Digital Legacies in Palliative Care:

In a recent study highlighted by palliative care professional Sarah Stanley, the growing importance of digital legacies is emphasised. Stanley points out that the impact of losing access to a loved one's

mobile phone, filled with digital memories, became a surprising revelation during the COVID-19 pandemic. Digital legacy encompasses information available about an individual after their death, including social media profiles, online conversations, photos, videos, gaming profiles, and websites or blogs. The research specifically focuses on understanding palliative care healthcare professionals' views on digital legacies. Stanley's insights underscore the urgency for more research in this area. As part of a broader study, her upcoming PhD will explore the knowledge and experiences of digital legacies among people in palliative care, caregivers, and bereaved individuals.
