Palliative Care Development in Ireland

Since the 1800s Ireland has had a rich culture of hospice/palliative care organisations. The voluntary hospice movement has been vital in the establishment of specialist palliative care services.

Together with the Irish Cancer Society (established 1963), the Irish Hospice Foundation (established1986) and the Irish Association for Palliative Care (established 1993), they have championed the holistic approach that is the hallmark of palliative care and have been instrumental in advocating improved palliative care provision and in raising public awareness and education.

The Irish Association for Palliative Care (IAPC) was established in 1993, at a time when palliative care was not a medical speciality in Ireland. Born of the need for the small and diverse group of professionals engaged in the delivery of palliative care to come together to share and to learn and, most importantly, to promote the principles of palliative care, it has since been a collective and expert voice advocating and shaping strategic improvements in palliative care provision. Since the IAPC's formation, a number of policy changes have shaped the provision of palliative care and, with the establishment of the HSE (Health Service Executive) in January 2005, the healthcare service in Ireland has seen the largest programme of change ever undertaken in the Irish public service.

Current and Future Development

Palliative Care in Ireland continues to expand and develop and continues to be ranked highly by international standards. However there remains regional and intra-regional variation in the availability of specialist palliative care in specialist inpatient units with three geographic areas having no specialist inpatients units whatsoever, and some who have no specialist palliative care day services. Further, there is significant variation in service availability and composition of multidisciplinary teams both in the community care and acute hospitals settings.

Established in 2010 the National Clinical Programme for Palliative Care (NCPPC) aims to ensure that persons with life-limiting conditions and their families can easily access a level of palliative care service that is appropriate to their needs regardless of care setting or diagnosis. The Irish Association for Palliative Care (IAPC) will continue to work closely with NCPPC.

The Palliative Care Services - Three Year Development Framework (2017 – 2019) was launched in November 2017. The aim of the framework is to provide an improved and evolving quality palliative care service that meets the needs of individuals and their families in all care settings. Its ambition is to ensure a seamless care pathway across inpatient, homecare, nursing home, acute hospital and day care services. The overall objective of the Framework was to inform and direct the development of adult palliative care services, both generalist and specialist, in Ireland for the three-year period. In so doing, the focus of the Framework was to identify the gaps that exist in the current level of service provision and to present a set of recommendations and actions which over the duration of the Framework (and at times beyond) would seek to address these service issues / deficits, subject to available resources.

The Irish Association for Palliative Care (IAPC), as the expert voice for palliative care, is committed to supporting the implementation of the recommendations on the Framework, and will engage in the development of an updated government policy based on the revision by the Department of Health of the 2001 NACPC Report, to take place in 2018 – 2019.

FOREWORD

As Chairperson of the Irish Association for Palliative Care and on behalf of the IAPC Board of Directors I am delighted to present to you the IAPC Strategic Plan 2018-2021.

Established in 1993 as an all island body with the purpose of promoting palliative care nationally and internationally, the Irish Association for Palliative Care (IAPC) is a multidisciplinary membership organisation. The membership reflects the entire spectrum of all those who work in or have a professional interest in the provision of palliative care. As the sole membership organisation for those involved in the provision of palliative care, the IAPC is the primary collective and expert voice for palliative care in Ireland.

The strategic aims of the IAPC are to:

- Challenge whenever it is appropriate, both internally and externally, to ensure good palliative care policy and practice in Ireland
- · Collaborate with others to ensure good palliative care policy and practice in Ireland

The Association will pursue these aims through providing structured opportunities for networking, sharing and learning, educational offerings, promoting and showcasing research, promoting evidence-based practice, publications, representation on national bodies and influencing the development and implementation of national policy.

The IAPC provides the forum for the full multidisciplinary context which is Irish palliative care in the 21st century.

This Strategic Plan is about supporting a strong, independent voice which will enable us to embrace the challenge of future-proofing palliative care and enabling every person with a life-limiting illness to live as well as possible until they die.
